#### 14. President's Report - KM

Welcome friends,

Over July and August, I continued to meet with the Faculty Association, PEA and CUPE 4163 and the GSS on growing concerns on what the return to campus would be like come Sept 7th. On June 24th we sent a joint letter to the UVic administration regarding air flow, the reliance on the go forward guidelines.

"We are also aware that the government will be removing mask mandates before the fall, and the university seems unwilling to mandate masks anywhere on campus in the absence of government requirements. Given our concerns for the health and safety of our members, we respectfully request that the University consider mandating masks in all university buildings".

Their response on July 5 was this "Our practice to date has been successfully guided by Dr. Henry and her team, and we have every reason to continue to trust her judgement and the expertise on her team and at WorkSafeBC. The BC Restart indicates that masks in public indoor settings will be a personal choice during Step 4"

Again, UVic was only willing to do the bare minimum. As you are aware, our local ran a survey on August 17, 2021 asking members what they would support for the fall re-opening plan with the Delta variant causing the COVID-19 case count to surge. 86% of members who responded had agreed that CUPE 951 should advocate that the University ask the BC Government to allow UVic to mandate all members of the university community, who will be working or studying on campus, in the fall of 2021 be fully vaccinated, unless they meet medical or religious exemptions.

Our local worked with the Faculty Association, PEA and CUPE 4163 to issue a press release on August 24, 2021 advocating for further measures to be put in place by the University. Can be found on our website.

I understand that members were not 100% in favour and our local will continue to represent the needs of all members as the University moves to implement this new plan.

Within all of this our executive also had a strategic transition retreat via zoom on July 7<sup>th</sup> to map and plan the next year from a bargaining survey, reviewing our territorial acknowledgment, looking at other ways to communicate, Instagram/YouTube, creating a Diversity Member at large position, trustee training, doing a privacy audit, executive training though CUPE National.

I am hopeful that as the fall slowly starts to get back to a better place our committees will start to thrive again with some new folks willing to help carry the load.

We have grown over the past 2 years leaning how to pivot to embrace new ways to hold meetings to stay connected with you. I realize how this has opened opportunities to give a small amount of meaningful time to allow us to keep everything moving on your behalf.

I wish to personally thank our stewards and executive who have made it possible for our local to steady the storm so many of us are facing throughout this pandemic. When we all work together we are at our best.

#### 15. Chief Steward's Report

Remote work opportunities: it's a department by department decision; they can approve or disapprove whether to have any Remote Work Arrangements (RMA); all the union can do is make sure everyone within a department is treated equally – i.e. if two people apply doing the same job, one can't be approved and one not be approved.

The Union doesn't and can't object to the University's vaccination policy (i.e. disclose your vaccination status and if not vaccinated or you don't disclose, then you must undergo weekly rapid COVID testing); there is a third option if you don't want to get vaccinated, or don't want to disclose your vaccination status and you don't want to submit to the rapid testing, you can take an unpaid leave of absence.

#### **CUPE BC Statement on National Day for Truth and Reconciliation**

CUPE BC's Executive Board today issued the following statement:

This Thursday, September 30, is the first observance of the new federal statutory holiday to mark a National day for Truth and Reconciliation. CUPE BC supports reconciliation, and we hope that CUPE members in British Columbia will look at September 30 as a day of commemoration to honour the Survivors of Indian Residential Schools, their families and those affected intergenerationally. This is not only a day to mourn and remember the children who never came home, but to find individual ways to learn more, share more and create a path forward toward reconciliation. The establishment of this national statutory holiday is Call to Action #80 of the 94 Calls to Action from the Truth and Reconciliation Commission (TRC).

The recent discovery of thousands of Indigenous children buried in unmarked graves on the sites of former residential schools across the country has heightened the awareness of Canada's racist and genocidal residential school system.

We know that September 30th is going to be a very difficult and challenging day for Indigenous survivors and their families, and we urge anyone who needs assistance to reach out for help by calling the Indian Residential School Survivors Society crisis support line at 1-800-721-0066.

To mark this first observance of Truth and Reconciliation Day, CUPE BC will be making two donations of \$5,000 each to the <u>First Nations Child and Family Caring Society</u> and the <u>Orange Shirt Society</u> to assist with the essential work these organizations are doing to support survivors and to shine more light on the incredible damage done to generations of Indigenous people. CUPE BC will also purchase 200 copies of "Spirit Bear: Honouring Memories, Planting Dreams" by Cindy Blackstock, and will be sending a copy to every CUPE Local in the province. The book is a resource for learning about topics of reconciliation. Reconciliation means something different to everyone, so do your own learning and begin the journey in solidarity with Indigenous people.

CUPE BC is calling on the B.C. government to honour the TRC's Call to Action #82, which asks each provincial government to work with Indigenous Survivors to commission and install a Residential Schools Monument in each provincial capital.

We strongly encourage all CUPE members—and all British Columbians—to learn more about the destructive legacy of residential "schools" and the ongoing effects that we also ask that people wear an orange shirt to show solidarity with Survivors and their families, and to remember and mourn the children who never returned home.
